A regular meeting of the Board of Directors, Aspen Springs Metropolitan District was convened on December 10th, 2024 at 6:00 p.m. at the Aspen Springs Metropolitan District building located on Metro Drive in Unit 5 Aspen Springs Subdivision. Elected board members Kenneth Barber, Kelly Evans, Pam Wallis, Eric Davidson, & Chris DeVries were in attendance. Two employees attended. No property owners attended.

Call to Order

Meeting was called to order at 18:00 by Kenneth Barber

Approval of previous Minutes

 November's minutes were approved. The copies presented had an erroneous name, which had been corrected for the permanent record – Motion: Kelly, 2nd: Pam, Passed unanimous

Public Works

- Carey: Vandalism and theft occurred at the Buttercup Water Station last week, the lock on the door was damaged and approximately \$120-125 was stolen out of the cash box. Pam shared the camera system flash drive with pictures of the perp with the County Detective as part of filing the police report.
 - OK to purchase new camera designed to work in low light/infrared
 - o Need to get the PIN for the Camera system
- The water station has electrical issues, with heaters only lasting a week. Mike S. has some electrical repairs to make (\$160), but system needs an overall health check by a Licensed Electrician.
- Property on Oak Drive, Unit 1, has an apparent well leak. The property owners are not around, and the water is leaking into the ditch, freezing, and running across Oak. Need to contact property owner.
- Requesting clarification on Water Truck replacement:
 - O Since we have \$45k in the 2025 budget, find a suitable replacement, Hi Wt Spec, and prefer a pre-Def powerplant. Can do so at any time. Once replacement is procured, Black Peterbilt can be retired, broken down to the platform level, and prepared for sale.
- Requesting clarification on Pay Raises:
 - o Actual for 2024 is the same as budgeted for 2025 (\$50k increase)
 - Motion: Kenneth proposed to give Carey the option to increase one or more employees' wages by 5% for 2025. 2nd Eric, passed unanimous.
 - Carey stated everyone will get 5%, and there were no complaints from the board.
- Pam: Wrote a letter to Elite Disposal Services that they (and their customers) cannot park garbage cans in the Right-of Way at the Oak Ridge, near the Postal Box Clusters. It is a school bus stop, and children do not need to congregate around trash blown over before pick-up. The Archuleta County website clearly stated they have no authority to leave cans within the easement area.
 - o **Pam** to send a copy of the letter to the other board members.

- Indian Land Road: In addition to the discussions from last month, it seems that Sheriff LaRue is on-board with enforcing any agreed-upon sign changes. Much discussion ensued ... with two main schools of thought:
 - o A: Road closed to public traffic from 01 November to 01 April
 - o B: Drive at your own risk. Drivers must comply CO traction laws.
 - o Both would be run past the Sheriff for input.
- Stollsteimer definitely needs widening work. The cliff off the edge of it is a greater danger than the one off of Indian Land Rd.
- Eric: Request from Judy Wesner for water receipts? Pam: Yes, wrote an email to her showing that her son would have spent ~\$52 at Buttercup station.

Treasurer's Report

- Kelly stated the budget overall looked good, with revenue at 109% and expenses at 104% of original year-end budget hence the Oct. revision.
- There was no payment of \$2,500 from OHPOA in 2024.
- Motion to approve November's Treasurer's Report Chris, 2nd Pam, Passed unanimous

 - o Resolutions were signed and attested
 - Chris also provided as required, "Budget Message", signed by Kenneth, and a "Service Plan" for submittal to Department of Local Affairs (DOLA)
